Touched by brokenness

Christian life is following Jesus, who perfectly ordered his human strengths and desires to God's will. It is, in fact, in such a rapidly changing socio-political world and its persuasive ideologies that embracing a God-centered and service-driven life dedicated to caring one's brothers and sisters acquires greater relevance and meaning. Although there are many other religious Orders serving the sick, a Camillian way of service is distinctive and unique. Letter from the Superior General

to all the provincials, to the vice provincial of Peru, and to the provincial delegates

Subject: Contributions to the General Curia 2023

Dearest Superiors,

Health and Peace!

As you know, the Generalate, having very little economic revenue, basically sustains itself with contributions from the Provinces, Vice Provinces, and Delegations of the entire Camillian Order.

As 2023 is the first full year of the six-year term that began after the General Chapter of May 2022, the General Consulta heard the opinion of the Central Economic Commission that met in Rome from January 16 to 19 this year and reviewed the contributions to the Generalate from individual Provinces, Vice Provinces, and Delegations.

The criteria for determining dues are practically the same as those set by the previous Consulta in the year 2021 and which, with some adjustments, we list below:

- A separate contribution is established for the Taiwan Delegation (the Order's constituencies called to contribute will now be 18).
- 2. All 18 constituencies must contribute to the sustenance of the General Curia.
- The economic needs to be covered (Generalate budget) are divided according to the economic capacity of individual constituents.
- Starting from an average quota determined by need, five types of quotas are established.
- All constituencies keep the previous year's quota unchanged.

Attached is the complete list of the new annual dues set for each constituency called to contribute financially to the General Curia and the comparison with previous years. As you can see, the total contribution of the provinces toward the Generalate increases for 2023 by 30,000 euros. We would have liked to lower

the dues, but the maintenance of the Enrico Rebuschini House (almost empty), the need for air condition units in some parts of the Generalate to brace for the increasingly high summer temperatures and the high inflation in Italy (in 2022 it was 8.1%), led us to this decision to increase the contributions to around 4.03%.

In the coming days, the General Bursar will send you a letter with the contribution quota for the first quarter of 2023. I sincerely thank you and your province, vice province, and delegation for the financial support you generously and fraternally continue to lend to the Generalate.

I wish everyone a happy celebration of the World Day of Consecrated Life and the commemoration of the Conversion of our Founder.

May St. Camillus bless you, your province, vice province, delegation, and all the confreres!

Dearly beloved, the new General Council elected at the General Chapter of May 2022, upon the recommendation of the Central Economic Commission, has seen fit to convene a Formative Meeting for Provincial, Vice-Provincial and Delegation Bursars. The meeting will take place in Rome at the Salesian Institute San Tarcisio located at via Appia Antica, 102 (within the vicinity of the Catacombs of Saint Calixtus) from June 26-30, 2023. It will begin with a dinner on Sunday, June 25, and will end after breakfast on Saturday, July 1.

The meeting will revolve around the three objectives or aspects:

- Fraternal: meeting of bursars to share experiences, joys, difficulties affirming the sense of belonging to the same family.
- Motivational: trying to reflect the teachings of the Church and the Constitution that call us
 to take seriously the management of the goods of the Order.
- Technical: the training and practical exercise (seminar-workshop style) on how to register
 in compliance with the established content, form and timelines, the comprehensive annual
 economic report of the Province, Vice-Province or Delegation to be presented to the General
 Council. Special emphasis will be made on drafting the notes to the annual economic report.

Allow me to highlight to each and every one the importance of the theme for the ordinary activity of the bursars, for the project management of the Province, Vice-Province or Delegation and their interaction with the General Council. For such an appointment, please extend the participation aside from you, to your collaborators (religious or lay) who support or assist you in the preparation of budget and annual reporting. We are now finalizing the program, which will be communicated to you as soon as possible together with the registration form.

To all provincial and delegation bursars please take note of this appointment in your agenda, trying to the best of your ability to attend doing everything possible to participate in this international meeting. Report of the Council Meeting held at St. Camillus Provincialate from 08th to 11th March 2023

1. Forthcoming Meetings in Rome

The Annual meeting of the Major superiors of the Order of the Ministers of the Infirm with its Superior General and Consulta will be held in Rome from 04th June to 10th June 2023. Provincial will be participating in the meeting. The meeting the Provincial bursars of the Order will be held in Rome from 25th to 28th June 2023. Fr. Lijo Patathil, the provincial bursar will participate in the meeting.

2. Requests for Admission to Novitiate

Fr. Jofree Nakuzhikkattu presented the community reports and requests of 8 prenovices namely, Thundathil Amalson, Amarjit Lugun, Asish Kujur, Bipin Minz, Dhiraj Lugun, Harshit Topno, Junesh Mallick and Lukas Marak who are willing to enter the stage of Novitiate formation with their full knowledge and free will. Provincial and Council after evaluating their reports and recommendations of the formator and community of pre-novices, approves their requests and admits them to Novitiate.

3. Requests for Renewal of Temporary profession

Master of the Professed presented the requests of Bros. Munjanattu Albin Thomas, Samuja Nayak, Sikendra Singh, Sumesh Kuruthukulangara, Able Jose Kappukattil, Absalin K., Rohit Dhanwar, Sumit Barla, Kalarpara Justin Job, Ponnamkudam Arun Sabu Paily, Nayak Prasad, Niravathinal Christo Joseph, Vayalamannil Ajin Joseph, Kalledayil Albin Joseph, Abinash Kujur, Thevarpadam Albin Thomas, Alwin Minz, Binod Dung Dung, Nishan R., Silarsan Bey, Paricha Bachan, Digal Bhaktinath, Attappattu Jinto Abraham, and Thachappallil Jithin Joseph for renewal of their Temporary profession of vows. Considering the growing need for the care and treatment of adults infected with HIV, Provincial and council permits the community to start the program with following conditions: The community shall obtain a written permission from the CWC to admit adults infected with HIV at the Centre, as the Centre currently takes care of Children infected with HIV. After obtaining permission, only patients who are on palliative care stage and/or needs continuous medical care shall be admitted at the Centre. In the event of failure to get the permission from CWC, the Centre shall provide Consultation, Day Care and counselling services. Provincial and Council further directs the community to move all adults currently rehabilitated at the Centre, other than the staff of the Centre, to an external facility.

7. Request from St. Camillus Seminary, Mananthavady

St. Camillus Seminary, Mananthavady requested the provincial and council an additional amount of Rs.140,000 for the repair and maintenance of the Xcent car, which has got major repair. After evaluating the condition of the car and considering the further utility of the vehicle for the needs of the community, provincial and council approves the request.

8. Request from Bp. Sebastian Adayanthrath

His Excellency Sebastian Adayanthrath, Bishop of Mandya Diocese has requested the provincial and council to avail Upasana community chapel for Sunday Holy Mass and Catechism for the migrant families. After discussing the request and in consultation with Upasana community, Provincial and council has granted the use of the chapel from 9.30 am to 11.30 am for the celebration of Holy Mass and catechism of children.

9. Committee to ensure the Ownership of properties of the province

Provincial and Council forms a new committee comprised of Fr. Bacil Singh (Coordinator), Fr. Lijo Pattathil and Fr. Shiju Kureekkattil to ensure the ownership of the properties of the Province. This committee will review the legal documents and records concerning the assets of the province/communities, and initiate necessary action to ensure that all its assets are free from any litigation and disputes in terms of their ownership.

10. Update about Snehadaan Hospital

The construction and renovation of Snehadaan hospital is nearing its completion. The blessing of the Outpatient and Emergency departments along with pharmacy and Laboratory of the hospital is tentatively scheduled to be held on 1st May 2023. An official inauguration of the hospital will be organized at a later date depending on the availability of all benefactors and other dignitaries who have helped in the realization of this project.

11. Annual budgets of the communities and Province

The provincial and his Council, taking the recommendation of the Economic Commission, discussed in detail the proposed and scrutinized budget of the province, and approved a sum of ₹136,659,437/- (Rupees One Hundred and Thirty-Six Million, Six Hundred and Fifty-Nine Thousand, Four Hundred and Thirtyseven only) as the total budget of the Province for the financial year 2023-2024. Subsequently, the following budget is approved for the respective communities/ ministry centers of the Province.

purchase of hospital equipment, Rev. Fr. Minutes of the General Assembly held at St. Camillus Provincialate, Bengaluru on 2nd February 2023

Assembly prayer

The general assembly began at 9.15 am on 2nd February on the day of conversion of St. Camillus. Fr. William led the prayer. After the prayer Fr. Teji welcomed the gathering.

Words of welcome

Fr. Teji Anickattuvayalil welcomed Rev. Fr. Bijoy the provincial, Sr. Lilly Rose, the provincial of Daughters of St. Camillus, Sr. Catherine DSC, provincial councilor and Sr. Virginia Rajkumari SAB, the chief speaker of the day and all the other confreres who participated from different communities.

The election of secretory and moderators

This was followed by the election of the assembly secretary for which three names were proposed, namely Fr. Patrick, Fr. Sunil, Fr. William. Fr. William withdrew due to his back pain. Fr. Patrick Nayak was elected unanimously as the secretary. After the election of the secretary, the election of moderators took place for which four names were proposed: Fr. Jofree, Fr. Prakash, Fr. Jaison Narikuzhyil and

Fr. Biju Sebastian. Fr. Jofree secured 19 votes, Fr. Prakash 13 votes, Fr. Jaison 13 votes and Fr. Biju Sebastian 16 votes. Frs. Jofree and Biju Sebastian were elected as the moderators of the assembly.

Introducing the speaker

Fr. Benny Chengalikavil introduced the chief guest of the day Dr. Sr. Virginia Rajakumari SAB and invited her to enlighten the members of assembly with her reflections on synodality.

Keynote Address

Fr. Biju was the moderator of the morning session. He invited Sr. Virginia to share about synodal life. She shared the following thoughts in

- The meaning of consecrated life is 'to be different' and Camillian ministry completely is also different from other ministries and charism
- It was a prophetic mission that was entrusted to St. Camillus
- Synod invites us to communion, participation and mission
- Communion: it is explained as 'meeting' and it is to come together,

- meeting face to face, knowing person to person and sharing the story of each other
- Participation: it is explained as listening. It requires patience, act of love, discerning and it is a mystery in itself. It also prepares us to speak well and helps us to reflect our relationship with God
- Mission: It is explained discernment. All our plans and actions need to have a discerning process. It is a give and take process
- She emphasized that a good leader should prepare five new leaders during his tenure
- Our identity comes from our charism and not from apostolic activities
- The intention of our founder is our identity
- Holy spirit should be part of our life and discernment

Discussions and interaction on the theme

Then, Fr. Biju Sebastian summarized the presentation and asked the gathering to raise two questions. Fr. Jofree asked about the speaker's suggestion for the synodality as for Camillian Charism.' Sr. Virginia responded saying that discerning would be the focus. When asked by Fr. William that 'what would be common platform for communion, participation and mission?' responded saying that the common platform is meeting the people. After the discussions Fr. Bacil proposed vote of thanks to Sr. Virginia and appreciated the commitment and witness of women at the crucifixion

and death of our Lord Jesus Christ and stressed the importance of women religious in the life of the Church. Fr. Prakash honored Sr. Virginia with a shawl. The assembly took a tea break for 20 minutes.

Sharing on synodal life

After the break Fr. Biju Sebastian introduced Sr. Catherine DSC and requested her to share her thoughts on Synodality. She shared the following points:

- Some treat synodality as catholic term while others treat it as a secular word. Few say it is the fruit of the second Vatican council, others see it as a theologicalpastoral vision of the holy father Pope Francis.
- Original intention of the creation of human beings was synodal.
- It is to bring solidarity with those in the peripheries of the church and the society.
- It is caring for the vulnerable members of our families. communities and society.
- As Camillians we need to be mothers of the sick and not brothers and sisters.
- It helps to check the authenticity of our religious discipline.
- The synodal dialogue depends on courage both in speaking and listening. If we want to truly live synodality we need to make three movements as given below:
 - 1. From emotional contagion to empathetic concern
 - 2. From action to attitude
 - 3. From being followers to being partners
- She spoke the three pillars of synodality as communion,

participation and mission.

- Communion: In communion we have to reflect on Trinity and the church is united by word of God and sacraments.
- Participation: It is a call for involvement of everyone amongst the people of God.
- Mission: Church bv very nature is missionary purpose therefore the communion and participation for the is mission.

Sharing on synodality

After the sharing of Sr. Catherine, Fr. Biju, the moderator invited Mr. Ranjith Xavier the president of Lay Camillian Family, Aluva for the presentation. Mr. Ranjith presented his personal life experiences with the help of concrete events and some of the points from his presentation are as follows:

- Personal experience of Gods' blessings and protection in all their activities
- Discipline among the members
- Gods' providence in times of difficulties
- Dedication towards the mission entrusted to the members

A short discussion followed after the presentations. Fr. Basil appreciated Catherine for the beautiful presentation. Fr. Siby Kaitharan clarifications sought some regards to the presentation of Mr. Ranjith and he responded to it. Fr. Christy congratulated both Sr. Catherine and Mr. Ranjith for their wonderful presentations and asked Sr. Catherine: "what could be done

concretely in the community to keep alive the synodality?" Sr. Catherine responded saying, that dialogue is very important among the members and everyone's opinion should be taken into consideration and make decisions together. Fr. William appreciated Mr. Ranjith for the wonderful presentation and asked what the Camillian Family expects from Camillian religious in the exercise of their mission. Fr. Biju Sebastian thanked both Sr. Catherine and Mr. Raniith and concluded the discussions.

Fraternal message

Fr. Biju announced that the recorded video message of Rev. Fr. Pedro Tramontin, the superior General would be communicated. Fr. General addressed the assembly from the cubiculum of St. Camillus, the place where St. Camillus' heart is kept. some of the points from his presentation are the following:

- Our reflection on synodality needs to penetrate through the Holy trinity.
- It leads us to ecclesial conversion.
- It makes us to turn to the Church, Scripture and History.
- We are first disciples of Jesus in the church which follows our charism.
- He urges us to listen to one another and to the Holy Spirit.
- Value the contribution that each individual offers to the family.
- We need to have fidelity to the initial inspiration of the founder.
- Listen to the many forms of sufferings and poverty of humanity todav.
- Christianity without tenderness is not Christianity.

- Walk everywhere as the children of God.
- Our mission is expressed in compassion.
- Our charismatic origin is synodality.
- Camillus understood that he could not do it alone so he is urging us to work together.
- All need to possess and give without possessiveness
- He urged us to live in communion, dialoguing together and collaborating with the Church.
- Need to have fidelity to charism and a renewed charism.
- We must be able to have an active participation and a united spirit in carrying out our ministry.
- We need to focus on the interprovincial collaboration. missionary attitude and promoting the laity while praying together and listening to each other.
- What God is asking in the church, He is asking us too.

After the presentation of Fr. General, Fr. Biju thanked Fr. Pedro and invited the gathering to discuss in the afternoon. Fr. Bijoy thanked Rev. Fr. Pedro Tramontin for his fraternal love and for sharing his insights with the gathering. He also thanked Sr. Lilly Rose DSC, Sr. Catherine DSC, and Mr. Ranjith. The guests were honored following Fr. Bijoy's thanks giving. Fr. Babychan honored Sr. Lilly with a shawl and Fr. Jaison N honored Sr. Catherine and Bro. Madhu honored Mr. Ranjith. Fr. Sunny led the midday prayer and the gathering proceeded

to have lunch. After the lunch break Fr. Iofree moderated the session and he invited Fr. Bijoy, the provincial to present the status of the Province.

Presentation of the status of the **Province**

the provincial began Fr. Bijov. his presentation saying, that the togethernessofthememberssymbolize that we are all one charismatic family. He thanked everyone for trusting him and giving him the responsibility to lead the province. He affirmed synodality as listening to one another in our communities with fraternal charity, willingness to accept, share, change and adapt to the plans and decisions. It's important to contribute vour ideas, talents and time for the community generously, while respecting one another, giving each one their space to work freely. We need to extend our collaborations with healthcare providers and other likeminded religious/civil associations. He gave the statistics of perpetually and temporary professed members and the number of seminarians in different stages of the formation. He made presentations on the following; members in the provincial council, offices of the province, legal entities of the province, special appointments, Camillian publications, members pursuing their studies, primary goals of the province, community and spiritual life, vocation promotion, formation, collaborative ministry, mission, ministries, members abroad, financial administration, future plans and time lines. He concluded his presentation

with a message from Pope Francis. The full details of the presentation of the Provincial will be sent to you in a separate file.

Financial presentation

Fr. Jofree summarized the presentation of Fr. Bijov and thanked him. He invited Fr. Lijo to make his presentation on finance. Fr. Lijo presented financial report and some of the points he emphasized were on the need of an effective management of all resources. coupled with the fundamental values of religious life, constant updates of new policies and laws. He said that we are also called upon to make necessary scrutiny on the FC money we receive. We must be extra vigilant at all times with regards to our lands and its documentations. He presented the annual budget in figures and the major construction projects in progress under which he spoke about Snehadaan Hospital Project, St. Camillus Ashram-Devalayam project -Hyderabad, and new house being built in Assam. He also presented about the legal issues related to construction of Yellampet and Snehadaan as well as about the different projects that province has been implementing. He concluded with the presentation of the current Financial Status of the province. Fr. Jofree summarized the presentation and thanked Fr. Lijo.

Major points for discussion

After the break the moderator Fr. Jofree read out the major points for discussion.

Formation

- To assign vocation promoters for each state.
- bring pre-novitiate novitiate program in the same house.
- To have an annual common meeting of all the minor seminarians.
- To prepare a specific guideline for the formation of the adult/delayed vocation.
- To allow the regents to have their year of regency in the same community.

There were some discussions of prenovitiate and novitiate program. Fr. Jobin enquired the reason for bringing pre-novitiate and novitiate together. Fr. Jofree responded saying about the possibility of getting more vocations in the coming years in Trichy. Fr. Baby N proposed to have pre-novitiate in Yellampet. Fr. Biju Sebastian responded to it saying that there could be danger of handling the disabled children by the young brothers due to their age. Fr. Siby K. shared that we need to have police clearance for the young age group to handle the disabled children. Fr. Bijov said that by bringing both groups together we can form them under one formator. Moreover, they will have enough time for settling in to the novitiate after having witnessed the formation of novices in the same place. If the program is in Yellampet, we need to have one more formator. Fr. William spoke about having higher secondary education (+1 and +2 studies) in Trichy because after one year as they go to a different state for their studies most of them can find it very challenging hence the chances of moving on are very dim. Fr. Bijov said that there were requests from Trichy and Eluru communities to allow the students to continue their pre-university studies in the respective places. He said the rationale behind bringing everyone to Mananthavady is to have the in-house classes and formation of these students and thereby to reduce the number of dropouts at that stage of formation. Would there be there be any challenges if they do not study +2 together? asked Fr. Christi. Fr. Jofree responded by saying that we are only thinking different possibilities. Fr. Jaison N. suggested that it would be good to send few students to Northeast to pursue their theology so that they can learn a different culture. Fr. Bijoy shared that it was decided in the previous Chapter that all the temporary professed would have their formation at Upasana, Bengaluru. Fr. Jofree added by saying that the teachers can come and teach inside the community and there are also possibilities of studying the science group. Fr. William reiterated that if students from Tamil Nadu go to study their +2 in other state there will be more dropouts.

Ministry

Fr. Teji read out the following points:

In line with beginning new ministries identifying the need of time is significant so we need to think of alternative ministries at Sneha Care Home, Snehagram and Snehasadan- a need for continuum of care of HIV adults is on the rise.

To increase the number ministry Centers and reduce that of formation houses.

Fr. Siby Kaitharan gave some details of the Snehasadan program, that they can't keep all the children together due to the new government rule. As the center is not getting any new admissions the present plan is to accommodate diverse categories of children in the center as the building has made new partitions as well as it has received the permission for the same.

Fr. Biju enquired the reason for increasing ministry houses reducing formation houses. Fr. Bijoy explained about the current/upcoming number of formation houses compared to the ministry houses that we have.

Finance

Fr. Basil read out the following points for discussion:

- To entrust the legal team to thoroughly go through all the property documents province and set them to have hassle free management of our assets
- cultivate а culture. documenting every matter importance in the communities and in our centers.
- bring about more professionalism in staff management - in matters fixing/incrementing their salary, allowances, duties, rights, permissions, leaves, performance appraisals, etc

- To make a patrimony and inventory of each house and province by systematically recording its assets and their values.
- To enable all the ministry centres towards self-sustainability strive to learn the best practices from established self-sustaining ministries/centers
- To whatever tap resources available for the sustainability of our ministries - be it from state/ central government or from NGO/ Corporates or from individuals

Fr. Jofree invited the gathering to have discussion and he himself commented that all the points appeared to be mandatory than mere suggestions. Fr. Basil reminded the danger of fake documents, which could cause us a lot. Fr. Lijo suggested to have a team that can work to update everyone regularly regarding the changing rules and systems. Fr. Jofree suggested to propose it to the provincial council. Fr. Siby Kaitharan gave a suggestion to get the help of a financial adviser. Fr. Bijov pointed out that updating of the land documents and assets are mandatory by siting the example of a fresh case coming against Snehadaan. He also suggested to appoint a team to examine and update the documents requested the communities to be up to date. Fr. Biju Sebastian recommended that we could find out a lawyer who has the knowledge of it like that of an auditor. Fr. Jofree the moderator closed the discussions on finance and requested Fr. Bijoy to read out the points.

Mission

Fr. Bijoy read out the following points:

- Proposal to rethink about the chapter decision of starting a 'formation house' in Odisha instead to ponder a ministry house
- The idea of 'more Order and less province'
- Proposal to widen the mission from hospital chaplaincy to ministries parish communities such as abroad.
- Province has some properties Kerala both donated and purchased for which we are vet to develop concrete plan.

Some of the proposals in this regard are the following:

- senior care homes
- diabetic and dialysis center
- Ayurveda health village

Fr. Bijoy proposed whether to grant the rights of the active and passive voice temporarily in the province/ delegation where they work. He also made clear about the interest of many of our confreres who are not willing to incardinate in the other province/ delegation. He clarified pointing it out that it will not affect the receipt of the salary of our confreres, which is a major source of the sustainability of the province in terms of formation and investments. Fr. Prakash mentioned that there are 11 confreres working under Anglo-Irish province. Babychan gave an opinion that active and passive voice should be decided by each individual rather than making it a policy. It is good to explain and consult our confreres living abroad.



Regarding discussion on parish ministries, Fr. Bijoy said that we have received invitation to have the possibilities of parish and chaplaincy ministries together abroad, but our general policy in many provinces is that we remain in the community while discharging our ministry. Fr. Babychan asked, if we have chaplaincy what is the need for the parish ministry, besides the Order does not encourage parish ministries. Fr. Bijoy responded saying there are several advantages like establishing a community of our own and building up more contacts in the parishes, which could help us actualize our various projects through fundraising. Fr. Jofree shared saying that there are Camillians working in the parishes in other provinces, and enquired concerning the restriction of the same when it comes to our province? He further said that while working in a parish, we could also do our ministry by means of visiting the family and the sick people. Fr. Jaison N said parish ministries are appreciated but community life is also important.

Regarding the discussion about the land at Thalavolaparamba, Fr. Biju Sebastian said if we want to have some ministry there, we need to broaden the road and for that we need to buy the land which would cost a lot. Therefore, it is suggested to sell the land in Kanjoor (many people have approached for the purchase of the land) and develop the other places. Fr. Benny shared about the Chekkichery land which has neither profit nor loss. Fr. Vince said we may get some profit this year. Fr. Bijoy asked the concerned communities to make an assessment about our unused properties and propose to the province, as that would be the best way to develop them. Fr. Babychan suggested to sell the land in Kanioor and buy a piece of land in Goa. Fr. Jaison N. pointed out that we are only in the south India and we need to expand our presence to other parts of India as well. Fr. Jobin said it is good to expand our ministry, but we need to have a very good plan before we make any move. He also added that our formees do not get the opportunities to experience the Camillian ministry and Charism. Fr. Deepu supported Fr. Jobin and said that most of us were inspired to carry on in our vocation by the ministry we saw and experienced.

Fr. Babychan made a point that the commission for the mission is missing in the presentation, and that there is a lot of balance amount. If possible, it could be utilized to support the Ugandan mission. Fr. Lijo responded saving we have some amount which we need to use for the Assam mission. Fr. Bijoy added saying that whatever balance is reflected is meant for specific purposes for which amount is already budgeted. Fr. Deepu suggested to appoint one of the senior priests to be the vocation promoter. Fr. Siby Areeparambil recommended that we need to have 10-year plan for any ministry that we begin. He also suggested to send more personnel for the education in the medical field. Fr. Sunil said that to respect the formation report of the rectors. Fr. Jaison suggested that it would be good to begin some education courses as we start the hospital in Snehadaan. Fr. Biju Sebastian gave an opinion that three presentations on synodality were not necessary and provincial team

could have asked the communities to propose some more points as part of the discussions. Fr. Bijoy responded saying that it was required because the theme of the assembly was synodality. The presence of our Camillian associates and their sharing added more meaning and did justice to the theme. With these questions and clarifications, the moderator winded up the discussions. Fr. Jofree the moderator invited Fr. Vince to propose the vote of thanks.

Vote of thanks

Fr. Vince thanked each and every one who contributed to the success of the gathering.

Fr. Bijoy in his concluding remark thanked everyone in India abroad for their active participation throughout assembly the announced the plans for the evening and the fraternity day. Fr. Jaison K. led the concluding prayer as we called it a dav.

The joy of hospital chaplaincy: Personal journey of a Camillian religious as a hospital chaplain in Bengaluru

He will wipe every tear from their eyes. There will be no more death, mourning, crying, or pain, for the old order of things has passed away. (Rev. 21:4)

do not remember when I first heard the word chaplain. Chaplaincy ■ ministry has been a topic of discussion in our conversations during our formation years, but I do not think I paid too much attention to it until ten years ago when God was calling through my provincial superior to serve as a hospital chaplain at St. Philomena's Hospital, Bengaluru. Now, it seems I have known it forever.

To be honest, I had little idea of what chaplaincy involved or what was required to be able to serve in it. Over the years, I realized that the calling to serve as a hospital chaplain is a noble and fulfilling vocation. It has been said that discerning God's will for a life is often a "lifelong quest" and that ultimately, people seem to know God has called them to chaplaincy ministry when they have a passion to 'carry each other's burdens' (Gal 6:2), and to provide ministry to the 'least of the brothers and sisters' (Mat 25:40).

Looking back, I can see how my life, up to this point, as a Camillian hospital chaplain in a multi-cultural context has transformed me and prepared me for impacting the hospital workplace for the good of the patients and healthcare workers through the chaplaincy ministry. More precisely, for Camillians in Bengaluru, our hospital ministry goes beyond providing spiritual and sacramental services to the sick. Fueled by a deep commitment to rendering motherly love to those in need, we become the means of healing and hope by engaging in pastoral conversations and spiritual listening. Our presence brings a sense of peace and reassurance in times of distress.

What was God calling me to do?

Proactively responding to the pastoral needs of the sick and hospital staff, the province started its first hospital chaplaincy ministry at St. Philomena's Hospital in 2013 and at St. Martha's Hospital in 2019. Today, it shines as a significant milestone in demonstrating the Camillian charism of mercy for the sick.

Though my calling to chaplaincy was clear. I needed to know the ways and means to get there. I now know I took the long way around, but I am grateful for the confreres, challenges, detours, and lessons learnt along the way.

Working as a chaplain in the hospital has been an enriching and spiritual experience for me. Revelation 21:4. "He will wipe every tear from their eyes. There will be no more death, mourning, crying, or pain, for the old order of things has passed away," served the priestly motto as a hospital chaplain. I am a witness to the longing of people to talk to someone with listening ears. I have encountered individuals and families seemingly helpless situations, yearning for a miracle. It has been humbling to hear people express their belief that God brought them to this hospital to meet me and receive God's blessings.

Amid pain and suffering, I have been grateful for the opportunity to be with people during their most challenging moments. I have listened to confessions from individuals who haven't confessed in years, some dating back to their first holy communion. Bringing them closer to their Catholic faith has been a profound privilege, and witnessing their return to the faith after many years has been truly inspiring.

As a chaplain, I have the privilege of providing guidance, strength, and comfort to individuals from various religious traditions. I offer prayers, blessings, and spiritual counsel that align with their beliefs and practices, fostering a sense of unity and respect among diverse communities. embracing and respecting the beliefs and practices of others, I created a space where individuals feel welcomed, supported, and understood.

What does it take?

Chaplaincy is immensely an challenging, constantly evolving, and profoundly fulfilling calling entrusted with bearing the presence of God in a broad spectrum of situations and cultures. As a Camillian chaplain, I provide unbiased care for all through the ministry of presence. I have encountered patients belonging to other faith traditions. As a chaplain in a hospital like St. Philomena's, the learning does not end. I am changed by the stories of miracles occurring when we pray over patients and offer them our care and support.

One weekend, I was the chaplain on duty. On the way to a patient's room, a couple approached me for a blessing. Although I have ministered to many requests for prayer, this encounter filled me with awe. I was taken aback at the faith of those couple who hung on to my cassock, requesting healing prayers. In all my humility, I prayed to God for help to minister to the couple. At that moment, compassion kicked in. I laid my arms and prayed; I remember feeling such peace when I realized that I was experiencing a sacred moment. This precious young couple had allowed me to share in their pain. That pastoral encounter taught me many lessons, not just about chaplaincy but also about my vocation as a Camillian priest chaplain. Though I would never see them again, the lessons of that faith encounter remain with me to this day. When I learnt the importance of listening, praying with, and focusing on the needs of the patient and family, I found my calling.

My ministry as a chaplain has affirmed my conviction that chaplaincy is a reciprocal journey of faith. As I share faith with those in need, I also obtain spiritual grace, fostering a deep, shared spiritual connection and a growing love for God. In my best moments, this is what I try to do, and more than casual conversations that can be endless discussions, I pray for the grace of pastoral presence. This considerable life challenge has had me reflecting on my time at the hospital, where I currently strive to practice a Camillian model of spiritual care that is about so much more listening and loving as a mother who loves her only sick child. It calls forth creativity, dynamic involvement in the life situations of the sick and their families, and an understanding of cultural contexts.

At the same time, each pastoral encounter has urged me to engage in my own healing, lean on others with an open mind and radically open heart, take risks to bear the burdens and always be willing to be changed in the process.

What did I learn?

To render motherly love for the sick is why Camillians exist. This goal encapsulates the joy of the Camillian charism of ministry to the sick. It expresses our deep commitment providing compassionate care. The joy comes from witnessing the transformative power of love and mercy in the lives of the sick. It is a joy that surpasses the challenges and difficulties we may encounter while serving the sick.

Interestingly, even the most seemingly routine patient visits can offer growth opportunities. Often, the lessons and God-experience come from those I am ministering to. While I found it a joy to minister to the sick and considered it a privilege: a sacred moment—to be allowed to enter into the pain of a total stranger, I found my calling.

Furthermore, the life of a Camillian religious as a hospital chaplain in Bengaluru is a testament to the power of compassion and mercy. Through our dedication, we bring solace and hope to the sick, embodying the charism of St. Camillus de Lellis. Our ministry goes beyond physical healing, touching the souls of those they encounter. In our selfless service, we reflect the love of Christ and inspire others to follow the example. May our presence bring comfort and healing to all who cross their path.

In essence, my goal is consistent: Respect and follow the charism of service to the sick for whom St. Camillus de Lellis, the saint of my heart, fought and died.

Compassionate care can change the world: A reflection on our identity, mission, and challenges at St. Camillus Ashram

He got up from the meal, took off his outer clothing, and wrapped a towel around his waist. After that, he poured water into a basin and began to wash his disciples' feet, drying them with the towel that was wrapped around him. (John 13: 4-5)

¬ spark service in solutions to our healthcare problems, we need to know the situation and plunge into it. As Camillians turned the page to write a new chapter of service to the most vulnerable, a significant part of their attention shifted, and so did their approach to the ministry they do. In the face of the overwhelming demands of differently abled children, they seized the opportunity to serve vulnerable children at St. Camillus Ashram Yellampet, Secunderabad.

Identity and Mission

Our conviction at St. Camillus Ashram is, "commitment is doing what you said you would do." According to Saint Camillus, our founder father, we are servants of the sick. What we are determines what we ought to do. This very fundamental nature that we have generates our purpose and mission at St. Camillus Ashram.

We are passionate about caring for differently abled children. When we generally share the kerygmatic message of the Gospel after the example of St. Camillus, we have a starting point. Namely, the specific ministry of service to the sick stated in the Constitution of the Order reads, "It has as its purpose, the complete service of the sick in the totality of their being" (Camillians, Constitution and General Statutes, art.10), which include physical, emotional, psychological, and spiritual care. This emphasis on all-inclusive care and service to the sick, even at the risk of one's life, is distinctive to the Camillian ministry of service to the sick.



Furthermore, our understanding of St. Camillus' life of service to the sick is born from experience. Primarily, it comes from being Camillian religious, formed in the Camillian spirit, and called to serve the sick with fellow Camillians.

Service to the Sick: our privilege to love and serve Jesus

On the one hand, for St. Camillus to be Jesus for the Sick is an identification with Jesus, who is moved with mercy and compassion (Lk 10:25-37). On the other hand, to serve Jesus in the Sick means Iesus identifies with the Sick. These two dimensions are intimately related to one another. A contemporary Camillian experience demonstrates that this encounter is not an abstract situation. Instead, it is the sick persons with their face, story, weakness, and limitations in the presence of Christ

(Calisto Vendrame, Camillians Today, 6).

The awareness that Jesus is present in the sick demands from the minister of the sick an attitude of respect and reverence, compassion and love, for indeed, the life of the person they serve is sacred. Therefore, it is another privilege given to us, the Ministers of the Sick at St. Camillus Ashram, to encounter and serve the Lord Himself the vulnerable, especially in children entrusted to our care. As Saint John Paul II notes, the sick become an "icon" of the suffering Christ, a window revealing the hidden Jesus Christ "in the face and the flesh, in the hearts and the minds of those suffering sick" (John Paul II, "Patients are An Icon of Christ," Camilliani-Camillians 23, Winter 199, 4-15; the main reflection point of the talk given by Pope John Paul II to the staff and sick people at


the Daughters of St. Camillus' Hospital in Rome on April 1, 1990). We do for the sick as we do for Jesus himself.

Our service to the sick becomes our divine worship, for wherever the ill person is, God is. Our meeting with the sick celebrates joy and contentment in life. True to the words, "The bed of the sick becomes an altar," around which the liturgy of healing service is celebrated (Mario Vanti, St. Camillus de Lellis and His Ministers of the Sick, 317), we at St. Camillus Ashram experience the presence of God in service to the children. Thus, by selfless service, Camillians and other caregivers integrate action (service to the sick) contemplation (experiencing Jesus in the suffering).

Our inspiration: St. Camillus de Lellis

Camillus de Lellis grew into a servicecentered life through service, prayer, and Scripture. In his way, Camillus revolutionized the services offered to the sick in the hospital. He prioritized the sick regarding service and support, sought out the sick and the abandoned, and adored them. "The whole purpose of my life," Camillus said, "is to serve the sick as if they were my king and masters because in serving them, I serve Christ our Redeemer" (Vanti, St. Camillus de Lellis and His Ministers of the Sick, 21).

As a renewed servant of the sick. Camillus was full of love for the sick. Mario Vanti remarks that Camillus was no genius as far as the administration was concerned. However, his piety and



generosity were known to all, and this was counted. In all his duties, Camillus proved to be a good and diligent servant (Mario Pucci, St. Camillus de Lellis, 78). Accordingly, the life of Camillus was concerned with the exercise of the ministry of service to the sick.

Just as Camillus was exemplary in the way he served the sick by attending to patients with ulcers and even the filthiest, being physically close to the patients, treating them with diligent charity, serving food, fixing their beds, and catering to the sick in all their needs and requests, (Sannazzaro, Camillian Order 1559-1699: A History, 64), we strive to live in proximity with the children.



Our experience is not about being hard and tough in the face of obstacles, but instead being able to stretch and expand without losing the original essence of our Camillain identity.

Taking action to share Camillian charism of mercy with the differently abled children in Telangana

The ministry project initially aimed at serving children with multiple disabilities. destitute. and occupational rehabilitation center. As a result, the San Camillo Occupational Rehabilitation Centre was inaugurated in 2016 at Yellampet. In addition, when the proposed home for disabled children was constructed in January 2017, four children moved in to live there. In the same year, the facility grew, raising the number of children to ten and eight staff members. The home for people with disabilities is named Daivalayam.

Daivalayam initiative

Daivalayam is an example of a Godly home. Building a home for children with multiple disabilities is one of the most challenging, creative, and demanding initiatives of the Indian province. Daivalayam means "temple of God". This is a place where children

with mental and physical disabilities are cared for and respected in the image of God.

Here, we are inspired by the compassionate and merciful love of JESUS for the sick, and we follow the example set forth by St. Camillus de Lellis, who considered the sick as his lords and masters. The Christian sense of service to the sick is different because it has another starting point: a relationship with Jesus and his servicecentered life. Therefore, such service to the sick follows Christ's example of service.

Serving as Christ served is the call for every Christian. Kenan B. Osborne, in his book Orders and Ministry, opines, 'The ministry of Jesus is a ministry of service (Orders and Ministry, 97). Thus, the foundation and model for all church ministries lie in the person and ministry of Jesus himself. This service attitude is very evident among Camillians who care for the sick. Therefore, we can affirm that 'service' is genuinely the primary word that we, as followers of Jesus, use after the example of St. Camillus to describe our relationship with the sick.

Currently, it accommodates 28 resident children and 19 staff members, of whom fourteen are residential and five are part-time. Most of the children are orphans with many disabilities and are referred by the Child Welfare Committee of the various districts of Telangana state. The St. Ann's Sisters offer children special education. Most of these children need constant personal care and attention.

Our experience is not about being hard and tough in the face of obstacles, but instead being able to stretch and expand without losing the original essence of our Camillain identity. In other words, it means 'being able to be there physically for the sick in their needs.' Each day, we look inward and reflect on the core of our mission, the essence of our ministry of presence.

Compassion requires passion for service

The compassionate healthcare services we have begun in Diavalayam have impacted children's overall health. Over the years, through various interventions, we made a conscious effort to improve comprehensive care and develop infrastructure. With this basis, we were able to transform and create a unique approach to our activities year by year.

Our commitment to care after the example of St. Camillus and faith in Jesus brought inspiring results, thanks to a newfound spiritual contentment. We realize they need compassionate care as we move forward to serve and connect. In this regard, we embarked on the following: (i) Personal care around the clock because they are mentally and physically disabled. Personal care includes feeding. bathing, and changing their clothes and diapers; (ii) Nutritional care is a significant aspect of health. Our nurses and caretakers pay special attention to the nutritional needs of each child. We provide exceptional nutrient food and feed them liquid food because most children cannot eat regular food; (iii) Medical care is accessible to address their needs. Doctors and healthcare professionals visit them regularly. Also, children are taken to the National Institute for the Mentally Handicapped (NIMH) in Hyderabad once every six months for various tests. A few of them take regular medicines for different health needs. In any health emergency, we transport the child to the nearest hospital, accompanied by a nurse or a caretaker; (iv) An in-house physiotherapist part-time attends to their regular physical exercises. education at Manovikas Kendra, a school for special children at Medchal, is a distinctive feature of inclusive care. Spiritual care service is integral to the ministry of service to the sick, which involves residents and staff on the campus.

Uniquely, we are driven by the example of Jesus at the Last Supper, who "showed them the full extent of His love" by washing their feet (John 13:1). Jesus surprised his disciples when he left his place and moved to where the servants worked. He wrapped a towel around his waist, filled a basin with water, and began to wash the dusty feet of his disciples (Jn 13: 1-5). As servants of the sick, we take up Jesus' example to meet the needs of our children to the best of our ability.

A collaborative ministry

Our mindset is collaborative. In less than two years, we opened our doors to members of other religious Orders and priests to collaborate with us and to become sweet extensions of God's mercy to the sick. Besides priests and religious, professional medical nurses, nutritionists, teachers, and

physiotherapists render voluntary services.

Not only did we commit to serving and fulfilling our set goals, but we also witnessed a stronger sense of pride and communion from the contributors who helped spread Iesus' love. This initiative is essential to spark a service attitude and that purposeful and responsible actions transform a community of vulnerable children into a community of dignified individuals.

Religious members other than Camillians residing on campus and practicing Camillian charism its uniqueness are distinct examples sound collaborative ministry. There are two religious nuns from Congregation of Sisters Adoration and one from the Blessed Sacrament living on the campus. They significantly contribute to the life of our institute and the charism through their committed service.

Challenges

Our more significant challenge is that there is more serving to do than servants available. As Pope Francis once said, full-time Christians don't sit down to admire their faith in the reflection of a mirror nor talk about it over dinner. Still, they come out of themselves, embrace their cross with courage, and walk the street to share with everyone the joy of the Gospel; we need servants with their hearts in their hands.

As a matter of fact, many personal doubts and questions arise in our hearts, as well as many whys. For example, why are these children born this way, why do they suffer the way they do, and how have they been orphaned and abandoned? These and other questions will have no definite answer. However, inspired by the exemplary example of St. Camillus, we embrace these children as precious iewels entrusted to us by God to care for, love, and serve, and thus seek to fulfill divine will through our charism.

In the same manner, the suffering of the innocent is a heart-breaking point to reflect on and understand. To our surprise, these innocent children serve as models for us to accept the sufferings in our lives with patience spiritual insight. Although obtaining committed staff is a constant struggle, we proudly meet their daily needs solely depending on Divine providence.

Our ministry in Daivalayam is indeed unique. At a time when not many are dedicated to staying at the bedside, we are witnesses to people of noble heart, like our Lord, taking the towel and bending their knees to wipe the feet of children. We admire all for doing it for the Glory of God!
